ANNUAL MEMBERSHIP DUES:

1. To receive a paper copy of the newsletter sent by U.S. Mail, plus a no-cost, emailed copy:

For current or recent (within past three years) members: **\$30**, due each January.

For everyone else, including new members: Your first-year dues will depend upon when we receive your application: January-February, **\$30**; March-May, **\$22**; June-August, **\$16**; September-October **\$8**;

November-December, **\$30**, credited as full payment for the current year and the following year.

2. To receive ONLY an online copy of the newsletter (no paper copy), sent as an email attachment: pay half (50%) of corresponding amount above.

FREQUENTLY ASKED QUESTIONS:
